The following application and any supporting documentation is due to the appropriate office no later than **5pm on Friday, February 18th.**

In addition to this application every student **MUST** register for the Housing Lottery via Self Service by **11pm on Friday, February 18th.**

All students are responsible for reading the Housing Lottery booklet published by the Office of Residential Education and Living and adhering to all information presented in the document, including dates and times. Any student requesting a housing accommodation must completely fill out the following application and register for the housing lottery on-line.

Students with permanent disabilities who require housing accommodations must request them each year. A student must register with the Office of Student Disability Services and provide current documentation in support of the requested accommodation for review by the Director of Student Disability Services. **Application materials of this nature must be handed into the Office of Student Disability Services.**

Students with a condition that is NOT permanently disabling who would like a related accommodation should contact Student Health Services or Student Counseling Services –depending on the type of impairment – to place the request each year. Included would be conditions that are temporary or less than substantially limiting to a major life activity, including recovery from an injury or surgical procedure and physical or mental health-related concerns. **Application materials of this nature must be handed into the Office of Student Health or Student Counseling Services.**
