Dear Student and Parent,

Connecticut College requires that all applicants for financial aid go through a process called verification. This means that our staff will compare information reported on the Free Application for Federal Student Aid (FAFSA) with pertinent federal tax returns, W2 statements, Verification Worksheet and other relevant documents.

Both the parent and student are required to complete and sign this worksheet but only after the FAFSA has been submitted. Failure to do so could jeopardize your eligibility for financial aid.

Once the verification process has been completed, your FAFSA might be sent back for corrections. You will receive a Student Aid Report (SAR) that will indicate what corrections were made. A revised award will be sent with a cover letter at the end of the verification process.

You can also make corrections to your FAFSA at [www.fafsa.ed.gov](http://www.fafsa.ed.gov). Once you have submitted the corrections, you will receive an updated transaction. Please let us know about those corrections so that our staff can review them.
