Dean, School of Liberal Arts and Sciences (SLAS), Baruch College, City University of New York, 1987—1995. Responsibilities include management of a budget of \$25 million and program planning for 2,500 classes offered annually to 12,000 undergraduates majoring in the arts and sciences, business, and education; administration of 16 academic departments with a full-time faculty of 230 and a part-time faculty of 350; and primary leadership in SLAS faculty recruitment and

evaluation, allocation of research support, development of outside funding, and organizing special events.
